7 **Call to order/Roll call**

8 Tim Terranova, appointed by L. Marx and acting as chair in Chair Marx's absence, calls the meeting to  
9 order at 1:00 p.m. ET.

10 A. Mortell calls roll. 3/6 voting members present. Committee does not have quorum.

- 11 • Chair Terranova announces that in absence of quorum no business will be conducted, no votes

14 **FY26 Quarterly Budget Review**

- 15 • A. Mortell provides an overview of the PA Compact Commission's quarterly budget report,  
16 which reflects expenditures from the first quarter of FY26. The FY25 expenditures have been  
17 updated with actualized costs, some of which were estimations when the committee last  
18 reviewed the budget in September 2025.  
19 ○ G. Thomas asks if the FY25 numbers are final for the whole fiscal year.  
20 ○ A. Mortell confirms.  
21 ○ C. Sims points out that the FY26 remaining revenue for AAPA and NCCA are inclusive of  
22 the request funds from both of those organizations, which would extend past the  
23 current funding agreement that ends in March 2026. Also, during August and  
24 September, there were charges to the commission general funds as the new HRSA grant  
25 was being put in place, and now expenditures will be charged to the HRSA funds until  
26 those funds are expended.  
27 ○ No further questions or comments from the committee.

29 **2026 Meeting Plan**

- 30 • Chair Terranova reminds the committee that all committees are to establish a routine meeting  
31 schedule for 2026. It is Chair Marx's inclination to set a regular quarterly meeting, with any  
32 additional meetings taking place as needed, along with monthly meetings between Chair Marx,  
33 C. Sims, and A. Mortell to review the budget and determine if any additional meetings were  
34 necessary.
